I understand that the risk of becoming infected by COVID-19 on a A&K trip may result from the actions, omissions, or negligence of myself and others, including, but not limited to A&K staff, service providers and other travellers. I agree to hold A&K harmless and voluntarily assume all risks and related expenses in the event that I, or any member of my travelling party, require testing, quarantine or become infected with COVID-19.

I understand I am required to follow the legal and regulatory requirements regarding COVID-19 testing and quarantine per individual country regulations. Any testing procedures and results during my journey are solely subject to the control of local governments. A&K has no control and no authority to overrule, change or amend local government policies as they relate to testing or providing private quarantine facilities. A&K will assist all guests where COVID-19 testing is required; however, A&K is merely acting as a facilitator in order to assist guests who require a COVID-19 test. All COVID-19 testing is carried out by third party testing facilities with no association or affiliation to A&K, and A&K is not liable or responsible for any results, issues, delays or problems encountered during the testing process or the performance or non-performance of the testing facilities.
